All students receive information about the educational process and enter into official correspondence with University officials via corporate e-mail.

An e-mail login and a password of the corporate mail are sent to e-mail of the student, through the personal account of the applicant

The lists of students divided into academic groups are approved and brought to the attention of students by the Head of the Department for Academic Affairs.

This information will be posted on the information stand for the first year students.

The classes begin according to the approved timetable. The timetable is posted on the website of the University no later than 31.08.2024.

Every student must check this timetable by himself.

In case of the conflict between the timetable posted on the corresponding SPbU information stand and the timetable posted on the website of the University, the timetable posted on the website of the University shall have priority.

During the academic year there is an intermediate certification in the form of a «test / exam» based on the curriculum for the relevant specialty in accordance with the timetable.
